### **Eligibility and Requirements:**

- Artist must be a current BBAC member.
- Up to two entries per artist. (more may be held in the back)
- Fee of \$5 per artist.

### **Artwork Regulations:**

- All work must have been painted outside from

#### **Direct Observation**

- Must be for sale
- Commission to gallery of 20% for sales
- Work on paper must be framed.
- Artist or designated agent entering and removing artwork at the end of the show must initial check-in and check-out sheet.
- Paintings must remain in the Gallery for the entire length of the show, unless sold

### **Matting and Framing Regulations**

- Size not to exceed 30" in height or width, Frame included
- All work on Paper must be framed
- all work to be hung on wall must be wired for hanging
- BBAC reserves the right to refuse entries that are obscene, controversial, or in bad taste.

### **Liability**

- BBAC will not be liable for damage before, during or after the exhibit.
- Artwork that adheres to the above guidelines will be accepted with the provision that BBAC reserves the right to reject any entry that is controversial, obscene or in bad taste.
