- **Up to 3 entries per artist as limited space allows**
- Fee waived for BBAC members. Non-members' \$25 membership fee only
- **Artwork must be original. Work should not have been displayed in a previous BBAC show. All mediums accepted.**
- No Artwork accepted after the submission date listed above
- **Artwork will be displayed at the curator's discretion-Contact Curators if any questions.**
- **All pieces meant to hang must be ready for display.**
- **If your piece is meant to stand alone, please provide a stand.**
- **All 2-D work should be wired to be hung on the wall. No saw tooth or single loop hooks allowed.**

- Originality: Must be Handmade and/or original.
- All Artwork must be for sale
- Commission to BBAC of 20% for sales at POP_UP Exhibit only. NO COMMISSION AT BANK
- Artwork that adheres to the listed guidelines will be accepted with the provision that BBAC reserves the right to reject any entry that is controversial, obscene or in bad taste.
- Artist or designated agent removing artwork at the end of the show must initial check out sheet.

Matting and Framing Regulations:

- All work to be hung on wall **MUST BE WIRED** to allow for secure hanging.

Liability

- BBAC and TEXPOP Museum will not be liable for damage before exhibit, during transport, during or after the exhibit.
